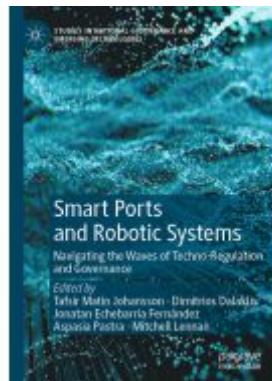
Details

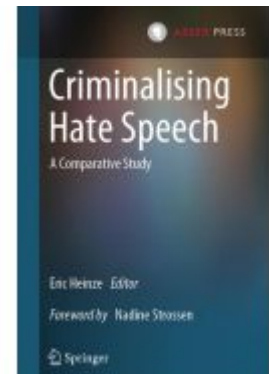

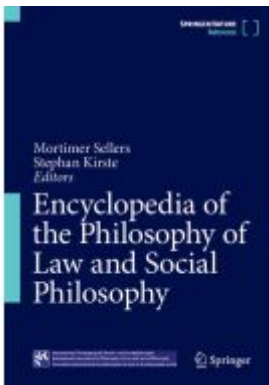
